WE CARRY PUBLIC LIABILITY INSURANCE RELATIVE TO THE SERVICES PERFORMED FOR THE OWNNER. A COPY OF THE INSURANCE POLICY HAS BEEN MADE AVAILABLE TO OWNER, AND THE OWNER ACKNOWLEDGES THAT HE/SHE IS FAMILIAR WITH ITS CONTENT.

WE ACCEPT NO LIABILITY FOR BREACH OF SECURITY OR LOSS OF OR DAMAGE TO THE OWNERS PROPERTY IF ANY OTHER PERSON HAS ACCESS TO THE PROPERTY DURING THE TERM OF THIS AGREEMENT.

WE SHALL NOT BE LIABLE FOR ANY MISHAP OF WHATSOEVER NATURE WHICH MAY BEFALL A DOG OR CAUSED BY A DOG THAT HAS UNSUPERVISED ACCESS TO THE OUTDOORS.

THE OWNER SHALL BE LIABLE FOR ALL MEDICAL EXPENSES AND DAMAGES RESULTING FROM AN INJURY TO US CAUSED BY THE DOG AS WELL AS DAMAGE TO THE OWNERS PROPERTY.

WE ARE RELEASED FROM ALL LIABILITY RELATED TO TRANSPORTING DOGS TO AND FROM ANY VETERINARY CLINIC OR KENNEL, THE MEDICAL TREATMENT OF THE DOGS AND THE EXPENSE THEREOF.

WE WARRANT TO KEEP SAFE AND CONFIDENTIAL ALL KEYS, REMOTE CONTROL ENTRY DEVICES, ACCESS CODES, AND PERSONAL INFORMATION OF THE OWNER AND TO RETURN TO THE OWNER AT THE END OF THE CONTRACT PERIOD OR IMMEDIATELY ON DEMAND.

I AGREE TO PAY

£25 PER NIGHT FOR THE FIRST DOG THAT IS BOARDING.

£15 PER NIGHT FOR EVERY SUBSEQUENT DOG THAT IS BOARDING FROM MULTI DOG HOUSEHOLDS.

£17 DAY CARE, £15 FOR SUBSEQUENT DOGS FROM SAME HOUSEHOLD (BETWEEN 9AM TO 5PM MONDAY TO FRIDAY ONLY)

ANY DAY CARE DOGS REQUIRING OUR COLLECTION AND DROP OFF SERVICE FURTHER THAN 3 MILES FROM HAPPY HOUNDS HERTS HQ WILL BE CHARGED £6.00 PER DAY (£3.00 EACH WAY)

BOARDING DOGS MUST BE COLLECTED BY MIDDAY AFTER THEIR LAST NIGHT OF BOARDING OR A DAYCARE CHARGE WILL BE APPLIED

EXTRA CHARGES OUTSIDE THESE HOURS WILL BE APPLIED.
